- Nomination papers must be delivered to the Returning Officer, Electoral Services, 3<sup>rd</sup> Floor, City Hall, Bradford, West Yorkshire, BD1 1HY on any day from the date of this notice but no later than 4pm on Wednesday, 3<sup>rd</sup> April 2019.
- If any election is contested, the poll will take place on Thursday, 2<sup>nd</sup> May 2019.
- Applications to register to vote must reach the Electoral Registration Officer at Electoral Services, 3<sup>rd</sup> Floor, City Hall, Bradford, West Yorkshire, BD1 1HY by midnight on Friday, 12<sup>th</sup> April 2019. Applications can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).
- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Electoral Services, 3<sup>rd</sup> Floor, City Hall, Bradford, West Yorkshire, BD1 1HY by 5pm on Monday, 15<sup>th</sup> April 2019.
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services, 3<sup>rd</sup> Floor, City Hall, Bradford, West Yorkshire, BD1 1HY by 5pm on Wednesday, 24<sup>th</sup> April 2019.
- Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Electoral Services, 3<sup>rd</sup> Floor, City Hall, Bradford, West Yorkshire, BD1 1HY by 5pm on Thursday, 2<sup>nd</sup> May 2019. The physical incapacity must have occurred after 5pm on Wednesday, 24<sup>th</sup> April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 24<sup>th</sup> April 2019.
